PIHVOT GRANT

OVERVIEW

As a company 100% dedicated to HIV, ViiV Healthcare is committed to supporting programs that will help address the challenges and gaps within the HIV cascade of care and help achieve 90/90/90 targets set up by UNAIDS.

Partnerships to Improve HIV Outcomes and Treatments (PIHVOT) is a grant program available to requesting Healthcare-Related Organizations (HCROs) to enable projects with the aim of improving health outcomes and quality of life for people living with HIV/AIDS in Canada.

ELIGIBILITY

Only Canadian HCROs are eligible. These are defined as private or public sector organizations, institutions, or associations comprised of Healthcare Providers (HCPs) whose main objective is related to the treatment of illness or the provision of healthcare.

CRITERIA

The PIHVOT project must:

- Focus on the HIV cascade of care (preference will be given to projects that focus on optimizing HIV care and/or quality of life)
- Support innovative approaches to achieve better health outcomes
- Be a maximum of 24 months in length
- Contain strong program evaluation

FUNDING RESTRICTIONS

PIHVOT grants cannot be used:

- For programs that have already occurred at the HCRO
- For capital expenditures (IT, medical equipment, etc.)
- For clinical studies
- To underwrite a commercial business or generate income for a customer, practice, administrative staff, or another healthcare organization
- To provide an individual customer with a direct or indirect personal benefit (including financial advantage or positive impact to reputation)

Requested funding cannot exceed 25% of the total HCRO annual revenue.

APPLICATION CHECKLIST

A complete application form must include:

- ☐ HCRO profile and qualification
- ☐ Proposed title, start and completion dates of the project
- ☐ Description of the unmet need to be addressed
- ☐ Description of the project (objectives, design, targeted outcomes, and milestones)
- ☐ Detailed budget and resources needed
- ☐ Proposed project partners
- ☐ Sustainability of the project

APPLICATION DATES AND PROCESS

The application process is made through the SmartSimple online portal:

viivhealthcare.smartsimple.ca.

First-time users will need to register before logging in to submit an application.

PIHVOT projects can be submitted 3 times a year, in January, May and September.

Applicants are notified of approval a maximum of 2 months after submission.

ADDITIONAL REQUIREMENTS FOR APPROVED PIHVOT GRANTS AND PROJECT FOLLOW UP

- Enter into a written agreement with ViiV Healthcare that will set out the amount of the grant, the milestones of the program, and payment dates
- Provide written project updates based on agreed milestones, including evidence of completion of program milestones (the report will trigger the payment up to the next milestone)
- Provide a final report
